IV. Method of Selection

V. Qualification

- 1. Those applicants having qualifications equivalent to any of the prescribed qualifications should submit the Certificate issued by the employer and without such certificate, their candidature will not be considered.
- 2. The minimum qualification stipulated for the post must be from a University / Institute recognized by AICTE/appropriate statutory authority in India/State/Central Government.

VI. Experience

- 1. Experience acquired after the date of passing of the qualification stipulated as per item I above will only be considered.
- 2. Experience Certificates obtained from Central/State Government Departments/SAI/ Companies registered under the Companies Act 1956 or Foreign Companies of equivalent status will only be considered for shortlisting to attend the Personal interview.
 - 3 . During the certificate verification process, the candidates should produce all certificates in original to establish the experience claimed in their online application, failing which they will not be permitted to attend the **Personal interview**.

 - 4. Applicants should not submit more than one application for a particular post. Application once submitted shall be final.

VIII. General

- 1. Applicants are advised to make sure that they are meeting the eligibility requirements for the post be fore submitting the applications.

Candidates short-listed for the certificate verification/Personal interview should bring a photo identity proof (in original) like PAN Card, Aadhar, Driving License etc., and all original certificates towards proof of age, qualification, experience and their candidature will be considered on the strength of the original certificates. Incase of failure to produce the original certificates, the candidature will be rejected.
- 4. Applicants who fail to produce the original certificates during the certificate verification process will not be allowed to attend the Personal interview.
- 5. No TA/DA will be paid to the candidates for attending the selection

- 8. Applicants should be of sound health and shall satisfy the medical fitness standards as fixed by the Government. A medical fitness certificate by the Medical Officer /Civil Surgeon shall be produced at the time of appointment.
